

About Our Agency

The Chinese-American Planning Council, Inc. (CPC) was founded in 1965 and has become one of the largest providers of social services for Asian Americans in the United States. Early Childhood Learning & Wellness Services (ECLW) is one of the programs offered by CPC's Community Services. ECLW is part of the New York City Child Care Resource and Referral Consortium (NYC CCR&R Consortium), composed of four culturally diverse child care resource and referral agencies in New York City, and funded by the New York State Office of Children and Family Services (OCFS). Our service goals are to serve the child care needs of families by providing information and referrals, as well as increasing the supply and improving the quality of child care services through technical assistance and training.

Our staff is multilingual in English, Chinese, and Spanish. We provide parents with free information on quality and affordable child care and assist them in navigating New York City's complex child care delivery system. In addition, ECLW offers Family Day Care orientations, training, technical assistance, and grants to potential and existing child care programs/providers, in order to increase the supply and improve the quality of child care services in New York City.

NYS Office of Children and Family Services' Regulations on Provider Training

All child care staff/employees/caregivers and volunteers with potential for regular and substantial contact with children are required by the New York State Office of Children and Family Services (OCFS) to complete <u>a total of thirty (30) hours of training every two (2) years</u>. Such training must address the following topics:

- 1. Principles of childhood development, focusing on the developmental stages of the age groups for which the program provides care
- 2. Nutrition and health needs of infants and children
- 3. Child day care program development
- 4. Safety and security procedures
- 5. Business record maintenance and management
- 6. Child abuse and maltreatment identification and prevention
- 7. Statues and regulations pertaining to child day care
- 8. Statutes and regulations pertaining to child abuse and maltreatment
- 9. Education and information on the identification, diagnosis, and prevention of the shaken baby syndrome

NYS Core Body of Knowledge (Core)

The Core Body of Knowledge, New York State's Core Competencies for Early Childhood Educators, was written for professionals who work directly with young children and was published by NYC Early Childhood Professional Development Institute.

- 1. Child Growth and Development
- 2. Family and Community Relations
- 3. Observation and Assessment

- 4. Environment and Curriculum
- 5. Health, Safety, and Nutrition
- 6. Professionalism and Leadership
- 7. Administration and Management

<u>Child Development Association Competency Standards and Functional Areas (CDA)</u>

The CDA Competency Standards are the national standards used to evaluate a caregiver's performance with children and families during the CDA assessment process. The Competency Standards are divided into six Competency Goals, which are statements of a general-purpose or goal for caregiver behavior. The following six Competency Goals apply to all child care settings:

- 1. To establish and maintain a safe, healthy learning environment;
- 2. To advance physical and intellectual competence;
- 3. To support social and emotional development and to provide positive guidance;
- **4.** To establish positive and productive relationships with families;
- 5. To ensure a well-run, purposeful program responsive to participant needs;
- **6.** To maintain a commitment to professionalism.

Registration and Payment Methods

Complete training registration form and include the training fee. **Training registration will not be completed without a \$10 commitment fee**.

**Most of our training courses are offered "free of charge" (with a \$10 commitment fee) to qualified Family Child Care providers and assistants. Note: Child care staff currently providing care to children may apply for SUNY EIP to cover training fees and can submit the SUNY EIP award.

CPC ECLW Training Policies

- 1. The maximum class size is 25 for the 30-hour Cohort classes; some have fewer seats to comply with guidelines set by the accrediting agencies. Registration is based on a first-come, first-served basis.
- 2. Registration and payment are required for ALL training.
- 3. Lateness to training will result in the cancellation of your training spot.
- 4. Payment received by CPC ECLW is non-refundable.
- 5. Certificates will be given to trainees upon completion of each training session.
- 6. With legitimate reason, the trainee may apply training credit for future training if s/he informs the office of cancellation 5 working days prior to the training. Credits can be used for future training offered by CPC ECLW within **one** year.
- 7. Children are not permitted to attend training sessions.
- 8. CPC ECLW reserves the right to change or cancel any of the training listed in this calendar. Training payments will be refunded in full under these circumstances.

Child Development Associate/CDA (120 hours)

- a. CDA is the most widely recognized credential in early childhood education (ECE). The CDA National Credentialing Program is based on the knowledge of the nation's leading scholars in early care and learning.
- b. CDAs are able to meet the specific needs of children and work with parents and other adults to nurture children's physical, social, emotional, and intellectual growth in a child development framework.
- c. Earning a CDA credential can improve your skills and confidence in working with children. It can also increase your opportunities for advancement in the early childhood field by helping you become eligible for positions such as Director, Group Leader, and Assistant Teacher.

Course Schedule

The 120-hour CDA course will run on 17 Saturdays. CPC will offer the 120-hour CDA in Chinese, English, and Spanish

- The Chinese and English 120-hour CDA courses started in October 2019.
- The Spanish 120-hour CDA course started in November 2019.

The new cycle of the 120-hour CDA courses will start in October 2020.

15-Hour SUNY Health & Safety Training

(OCFS 2, 3, 4, 5, 6, 7, 8, 9; Core: 5, 7; CDA: 1, 2, 4, 5, 6)

The 15-hour Health & Safety Training is mandated for any person who wishes to become home-based child care licensed provider in New York State. Health & Safety training is certified by the NYS OCFS. This is a competency-based curriculum that requires successful completion of written and demonstration tests. Health & Safety Training certificate will be given upon completion.

This training program meets the following OCFS content areas:

- Business Record Maintenance and Management
- Child Abuse and Maltreatment Identification and Prevention
- Identification, Diagnosis, and Prevention of Shaken Baby Syndrome
- Nutrition and Health Needs of Infants and Children
- Safety and Security Procedures
- Statutes and Regulations Pertaining to Child Abuse and Maltreatment
- Statutes and Regulations Pertaining to Child Day Care

30 Hour Cohort Courses

These sessions are designed to help fulfill the 30-hour requirement for initial licensing and renewal. All topics are taught by NYS verified trainers or NYS certified early childhood educators.

PITC: Temperament, Social Skill Development & Guidance

This training uses a variety of interactive learning activities to introduce the concept of temperament and its dimensions. The temperament tendencies of infants and toddlers will be explored and participants will discover and examine the influence of temperament on their relationships with infants and toddlers. We will also examine how an understanding of three stages of infancy helps adults attune their nurturance of infants and toddlers. The concepts of prevention and intervention are explored as well as specific guidance techniques appropriate for infants and toddlers at different stages of development.

Social & Emotional Development in Early Childhood and Safety & Prevention in Child Care

This training will be for two sessions. The first session will provide participants an understanding of what healthy social-emotional development is, its importance to later learning, and specific ways to support healthy social-emotional development. The relationships we build with children, families, and colleagues are at the foundation of everything we do with children. We know about the importance of relationships in terms of children's development and success in school. It is important to build these relationships with all children as a context for supporting their social-emotional development and preventing challenging behavior. It will be easier to address challenging behavior if we already have a relationship with the child. The last session will review Child Day Care Regulation Part 413, 417 and 416, as well as Sudden Infant Death Syndrome and Shaken Baby Syndrome and child abuse and maltreatment. Participants will learn the strategies to create a healthy and safe environment to promote learning.

Healthy Eating: Obesity Prevention in Child Care

Healthy eating habits and regular gross motor activities are both important components of a healthy lifestyle for everyone, especially for young children. Recent research tells us that today's children are actually not getting enough physical activity, which can lead to obesity and diabetes. Child care providers can be positive role models as they work with children in their care. The routines and habits that are started early in life will be easier to continue as the children grow. Whereas inactivity early in life will continue into adulthood, causing a serious risk of heart disease and high blood pressure.

Learning with our 5 Senses and Prevention of Toxins in Child Care

The purpose of this training is to guide participants on how to engage children to learn through their five senses. The provider will be able to design age-appropriate activities for young children to explore using their five senses which include the sense of hearing, sight, smell, taste, and touch. Children will promote their 5 senses in different areas with their body parts and provider will be able to plan the lesson with meaningful and interesting interactive activities.

The purpose of learning toxin prevention in child care is for providers to understand the dangers of toxic materials in toys and materials that children can access. We will explore different strategies and ideas on how to check materials and keep their homes safe for young children. Providers will expand their knowledge of what toxic is and how it affects children. It is important to minimize and remove toxins in their life so that young children could enjoy exploring the world safely, and give children the opportunity to enjoy quality activity time freely and safely.

Operating & Managing a Family Day Care

The purpose of this 6-hour training session is to:

- 1. Update provider with the latest OCFS regulation changes.
- 2. Refresh their memory on previous regulation, ensuring all participants fulfill their requirements as an FDC provider.
- 3. Financial management and risk management will be discussed during the session.
- 4. Providers will be briefed on the annual tax rate and deductible changes.
- 5. Educate providers on how to limit their legal and financial risks by purchasing the proper insurance.

For providers who are having enrollment difficulties, low cost or free marketing methods will be presented to them.

Adult and Pediatric First Aid/CPR

(Curriculum approved by the American Red Cross) (OCFS 1, 2, 3, 4; Core: 5, 7; CDA: 1, 2, 6)

This training combines lectures, interactive video demonstrations, and hands-on practice. It will prepare all caregivers with the first aid skills needed to act quickly and competently during an emergency, and how to prevent, recognize and respond to cardiac and breathing emergencies in infants and children under 12 until authorized medical personnel arrives.

Upon successful completion of written and demonstration tests, participants will be given an American Red Cross First Aid and CPR (adult and pediatric) certification which is valid for 2 years.

"On August 13, 2010, a law was passed that requires all child care providers to have at least one employee who holds a valid certificate in cardiopulmonary resuscitation (CPR) and first aid on the premise of the child care program during the program's operating hours. This law went into effect on December 11, 2010...Providers found to be out of compliance may be found in violation of the law and could face enforcement action."
